NOTIFICATION

No.SO(Estt)/PHED/4-1/2023: On the recommendations of Khyber Pakhtunkhwa Public Service Commission, the competent authority is pleased to appoint Muhammad Fawad Khattak S/o Bakht Ali Khan R/o District Karak/4 as Assistant Engineers/Assistant Design Engineers/ Sub Divisional Officers (BPS-17) (Rs.45070-3420-113470) in Public Health Engineering Department, subject to the terms & conditions mentioned below:

TERMS & CONDITIONS:

- i. He will be governed by the Khyber Pakhtunkhwa Civil Servants Act 1973 and the Rules framed there-under.
 - ii. The above post, for all intents and purposes, shall be within the definition of Civil Servants except for the purpose of pension and gratuity. In lieu of pension and gratuity, he will be entitled to receive such amount contributed by him towards Contributory Provident Fund (CPF) along-with the contributions made by Govt. to his account in the said fund, in the prescribed manner.
 - iii. He will, initially, be on probation for a period of one year, which is extendable as given in Rule-15 of the Khyber Pakhtunkhwa Civil Servant (APT) Rules, 1989.
 - iv. His services will be liable to termination at any time without assigning any reason before the expiry of the period of probation/extended period of probation, if this performance during this period is found unsatisfactory. In such an event, he will be given one month prior notice of termination from service or one month pay in lieu thereof. In case he wish to resign at any time, one month prior notice shall be necessary or in lieu thereof, one month's pay shall be forfeited.
 - v. He will not be entitled to any TA/DA on his first appointment as Assistant Engineers/Assistant Design Engineers/ Sub Divisional Officer
 - vi. His seniority will be determined in accordance with the merit assigned by the Khyber Pakhtunkhwa Public Service Commission.
2. If the above terms & conditions are acceptable, an **UNDERTAKING** to the effect, on a Bond worth Rs. 100/- signed and duly attested by the Oath Commissioner, should be produced in the Public Health Engineering Department Govt. of Khyber Pakhtunkhwa, within a month time without fail.
3. In case of failure of response of the above offer within a stipulated period, as mentioned above, the offer shall stand cancelled, subject to the extension for the acceptance by the Govt.
