TERMS AND CONDITONS. (B)

1. Biding documents including instruction to bidders can be downloaded up to one day prior to the opening date from PHE Web site (www.phedpk.gov.pk).
2. Tender documents/BOQ can be downloaded, after publication in newspaper/KPPRA Website, from Public Health Engineering Department web site www.phedkp.gov.pk.
3. Last date & time of submission of the bid is **24-08-2021 at 12:00 PM**, which will be opened on the same day at **12:30 PM** in the presence of contractors or their representative who opt to be present.
4. The percentage of bid security shall be 2% of the estimated estimate cost.
5. The contractors quoting the bids more than 10% below on Engineer's Estimate shall submit an Additional Bid Security equal to 8% of the bid cost along with 2% bid security at the time of bid submission.
6. If the successful contractor who has quoted a rate more than 10% below on the Engineer's Estimate and has repudiated the contract, the entire security deposit i.e. 2% security along with 8% additional bid security shall be forfeited in favor of the Government.
7. If the successful contractor who has quoted a rate more than 10% below on the Engineer Estimate and has repudiated the contract for three different times in different bids during the same fiscal year, then the entire security deposits i.e. (2+8) % shall be forfeited in the favor of the Government and contractor shall also be proceeded for blacklisting for a period of five years.
8. Sealed bids shall be sent through registered Courier service which must be reached in the office of the undersigned on or before closing day & time mentioned above. The bids received late shall not be entertained; any delay in delivery of tender documents will be responsibility of the bidders.
9. Tender rates should be quoted both in figures and words.
10. Successful bidders shall sign the contract agreement within 07 days after issuance of the acceptance letter.
11. Stamp duty/sales Tax and other Government Taxes will be responsibility of the successful bidder (if any).
12. The competent authority reserves the right to reject any bid or all the bids assigning cogent reasons.
13. Bids will be valid for Ninety (90) days.
14. Bids security of the bidders will be retained by the procurement entity till approval of tender or bid validity period.
15. All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act ibid, & having active status.
