TERMS AND CONDITONS.

- 1. Biding Documents including Tender Forms, BOQs and instructions to Bidders can be downloaded till last day prior to the opening date from PHED web site (www.phedkp.gov.pk). And can also be obtained from the PHED Office concerned including stamp paper format etc.
- 2. Last date & time for submission of the bid is **08-08-2023** at 12:00 (Noon) which will be opened on same date at 2:00 pm in the office of the undersigned.
- 3. As per **KPRA** regulation No. S.R.O(14).Vol:1-24/2021- 22 dated 10/05/2022 the contractors quoting their bids more than 10% below upto 20% below on Engineers' estimate shall submit along with their bids 8% Additional Bid Security of Engineer estimated cost accompanying 2% bid security. Similarly, a contractor quoting bid more than 20% below shall submit additional bid security equal to the differential amount of submitted bid and Engineers' estimate along with detailed rate analysis with bid].In case of more than 20% below bids if the bid is not accompanied by the detailed rate analysis then the said bid shall be considered as non-responsive, all the bid securities submitted along with such non- responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.

 - viii. The bidder will provide the certificate on Affidavit on Stamp-Paper duly attested by Oath Commissioner that the firm is not involve in any Litigation case with PHE Division Dir Lower.
 - ix. Additional call deposit in shape of CDR as Per KPPRA rules.
 - x. Tender fee @0.03% on bid cost in shape of CDR.

- 6. The Bidders are required to send their Bids through Courier Service and the bids shall reach the Offices before the closing date and time.

- 12. Only the contractor, as per rule no. 37A of Khyber Pakhtunkhwa Public Procurement of goods, works and services Rules 2014 (Rules) reproduced below necessitates that Registration of bidders with Khyber Pakhtunkhwa Revenue Authority (KPRA) is mandatory
 - "All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-Il of the Act ibid".

It is mandatory to have a certificate duly attained by the Office of Executive Engineer for the year 2023-24 regarding presence of Ware house containing all the basic equipments such as welding plant, Pipe line stock of several diameters, valves etc. Further it is also mandatory to provide the list of labor /staff working with the contractor along with their credentials. Further the location of warehouse must be located near Timergara/Chakdara whichever is nearer in distance. Incase of failure, the bidder shall be considered non responsive.
