

PHE Division Tribal District Bajaur, Government of Khyber Pakhtunkhwa invites Electronic Bids from Eligible Firms/Contractors in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) rules 2014 on "Single Stage, Single Envelop" procedures for the following works.

Terms & Conditions: -

- 1. Biding Documents including instructions to Bidder can be downloaded upto one day prior to the opening date from Public Health Engineering Department website address www.phedkp.gov.pk.
- 2. The Last Date & Time of Submission of the bid is <u>26-09-2023</u> at 12:00 PM, which will be opened on the same day at 12:30 PM in the presence of the Contractors or their authorized representative who opt to be present.
- 3. Participating contractors/firms are required to provide detail as well as skilled labors information including their names & CNIC numbers. Moreover, only those contractors will be eligible to participate who have their workshop/warehouse in Tribal District Bajaur.
- 4. The Electrical / Mechanical contractor must submit the Workshop verification certificate issued by Superintending Engineer PHE Circle Malakand at Timergara for 2023-24.
- 5. The contractor already working with PHE Division Tribal District Bajaur shall submit a performance certificate and inspection certificate duly verified by the Sub Divisional Officer.
- 6. The Bid Security, Additional Security, and detail rate analysis (If the quoted rate is more than 20% below on the Engineer's Estimate) shall be submitted as per KPPRA Notification No. S.R.O.(14)/Vol: 1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022, along with the bid in a sealed envelope before the closing date and time to the office of the undersigned.
- 7. Non-refundable bidding entry fee @ 0.03% of the estimated cost must also be submitted/furnished with the bid in the shape of a separate call deposit (in original) in the name of the Executive Engineer.
- 8. Any bidder who failed to submit the CDR and bidding fee before the opening of bids will be considered non-responsive.
- 9. The Call Deposits/Additional Security of all the contractors will be retained till approval of the tenders by the tender approving authority.
- 10. Each bidder must attach photocopies of CNIC, PEC Registration Certificate, Renewal Receipt, Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPRA for the current financial year with each bid/work.
- 11. The Competent Authority reserves the right to reject any or all the bids as per the provision contained in rule 47 of KPPRA Rules 2014.

12. All other Government Khyber Pakhtunkhwa bidding/tendering rules will be applicable
