The envelop mark as "Financial Proposal" must contain bid security @2% of the Estimated cost in shape of call deposit along with the stamp duty in the name of the Executive Engineer PHE Division Kohat and Non-refundable fee of Printing/ Reproduction cost of the Bid submission documents.
