GENERAL TERMS AND CONDITION:-

1. Bidding documents including instruction to bidders and others terms and condition can be downloaded up to one day prior to the opening date from PHE web site (www.phedkp.gov.pk).
2. Last date & time for submission of the bid is **06-02-2025** at 12:00 (Noon), which will be opened on the same day at 1:00 PM in presence of contractor or their authorized representative who opt to be present. Sealed bids (in original) should reach to the office of undersigned through Courier service before the closing date mentioned. The bids received late shall not be entertained.
3. All bidders are required to be registered with the KPRA.
4. (i) As per KPRA regulation No. S.R.O(14).Vol:1-24/2021- 22 dated 10-05-2022 the contractor quoting their bid up-to limit of 10% below on Engineer estimate shall submit a bid security to the extent of 2% Engineer estimate only.
(ii) The contractor quoting their bid more than 10% below up-to 20% below on Engineer's estimate shall submit along with their bid 8% **Additional Security** of Engineer estimated cost in addition to 2% bid security . if the bid is not accompanied with the required amount of additional security then it will be considered as non-responsive and the 2% security shall be forfeited in favor of Government and the second lowest bidder and so on will be consider accordingly.
(iii) **{similarly contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer 's estimated cost equal to the differential amount of submitted bid an engineer's Estimate along-with detailed rate analysis}** . In case of more than 20% below bids if the bid is not accompanied by the detailed rate analysis and/ or required amount of additional security, than the said bid shall be considered as non-responsive. All the securities submitted along-with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be consider accordingly.
(iv) In case detailed rate analysis submitted with the bid is, in view of the procuring Entity, not convincing, the head of the procuring Entity, may be declare such bid as non responsive without forfeiture of bid securities and record reason thereof.
(v) The procuring Entity may offer the contract to the next lowest bidder after due diligence in the context of financial difference such two bids may advertise procurement opportunity fresh
5. Bid entry fee@ 0.03% of tender cost should be submitted separately in the form of CDR (Non refundable).
6. Stamp duty cost mention in tabulated form also submitted separately in the form of CDRs.
7. All other terms and conditions will be as per KPRA rules, PEC, SBDs and other relevant laws.
8. Bidder shall have codes in PEC registration such as CE-09, an also required category C-5 for package-I & II at Serial No.1 &II as per criteria.
9. Govt Taxes shall be applied as prevailing.
10. Contractor must have enlistment duly issued by Provincial Enlistment committee, Khyber Pakhtunkhwa.
11. List of skilled labor & staff with affidavit should be separately provided.
