Technical Bids will be opened on the same day at 12:30 PM, by the bid's evaluation/procurement committee in the office of Executive Engineer Public Health Engineering Division Tribal District Bajaur, in the presence of bidders or their representatives who opted to attend. The date of the financial bid opening shall be intimated accordingly.
3. All bidders are required to be registered with KPRA (Active Taxpayer).
4. The bidder shall submit a Single Envelope (Sealed Bid), containing two separate sealed envelopes of Technical Proposal & Financial Proposals must contain of bid security @2% of the Estimated cost in shape of call deposit along with the stamp duty in the name of the Executive Engineer PHE Division Tribal District Bajaur and Non-refundable Bidding Entry Fee @0.03% of Tender Cost in shape of separate Call Deposit may be furnished (in original) to this office.
5. The Bid security and quoted rates on the BOQs shall be provided in a sealed Financial Proposal envelope and duly stamped with the firm/co. seals.
6. Additional Security shall be submitted as per KPPRA Notification No. S.R.O. (14) Vol:1-24/2021-22/6058-21 Dated: 10-05-2022.
7. The financial bid of the firm will not be opened in case of non-qualifying in the technical evaluation.
