- 1. Biding Documents including instructions to Bidder can be downloaded up to one day prior to the opening date from PHE Department website address www.phedkp.gov.pk.
- 2. The Last Date and Time of Submission of the bid is <u>23-07-2024</u> at 11:00 AM, which will be opened on the same day at 11:30 AM in the presence of the Contractors or their authorized representative who opt to be present.
- 3. The Electrical / Mechanical contractors have to submit the following documents during submission of the bid documents. i. License issued by the Electrical Inspector Certificate/License of the Firm of KPK duly renewed for the 2023-24 & 2024-25, ii. The contractors/firms are required to provide detail as well as skilled labors' information including their names & CNIC numbers, iii. Workshop/Warehouse Certificate.
- 4. The Electrical / Mechanical contractor must submit the Workshop/Warehouse verification certificate issued by Superintending Engineer PHE Circle Malakand at Timergara for 2024-25, in case of non-submission of the said certificate, the bidder will be considered as non-responsive.
- 5. The Contractors already working with PHE Division Bajaur shall submit a performance certificate duly verified by the Sub Divisional Officer.
- 6. The bidder must attach photocopies of CNIC, PEC Registration Certificate, Renewal Receipt, Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPRA for the current financial year with each bid/work.
- 7. The bidder while quoting their rates shall submit 2% bid security and additional security as per KPPRA Notification No. S.R.O.(14)/Vol: 1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022, along with the bid in a sealed envelope before the closing date and time to the office of the undersigned.
- 8. Non-refundable bidding entry fee @ 0.03% of the estimated cost must also be submitted/furnished with the bid in the shape of a separate call deposit (in original) in the name of the Executive Engineer. Any bidder who failed to submit the CDR and bidding fee before the opening of bids will be considered non-responsive.
- 9. In case of equal rates of two or more bidders, their bids shall be evaluated on their technical soundness and experience or a toss basis.
