- The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS before the last date and time for submission of the bid.
- The received technical bid (s) shall be opened (downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of bidders or their representatives who opt to be present.
- 4. The received bid (s) shall be evaluated as per the criteria mentioned in the solicitation documents.
- 5. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.
- 6. The date and time for the opening of the financial bid shall be announced after evaluation of technical bids.
- 7. The bidder shall submit the sealed bid with requisite documents, including 2% Bid Security (or additional security if required of the estimated cost in the shape of a call deposit (original) before the closing date and time.
- Bidders shall submit a tender form fee (non-refundable), i.e., @ 0.03% for each work separately in the shape of a call deposit receipt (CDR) to the Executive Engineer, PHE Division, Mardan.
- The bidders should submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
- Incomplete/conditional bids with unattested cutting/overwriting/disfiguring shall be considered as "non-responsive".
- 11. All the conditions/instructions given in the bid Solicitation documents shall be applicable on all competitive bidders.
- 12. The Procuring Entity (P.E) reserves the right to reject any or all bids, with cogent and valid reasons.
- 13. The bidder will provide an affidavit in the technical proposal that no Water Supply Scheme should stand unoperational for more than 24 hours.
