2. The bidder shall submit & upload the technical and financial bids [by file uploading] through EPADS before the last date and time for submission of the bid.
3. The received technical bid (s) shall be opened (downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of bidders or their representatives who opt to be present.
4. The received bid (s) shall be evaluated as per the criteria mentioned in the solicitation documents.
5. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.
6. The date and time for the opening of the financial bid shall be announced after evaluation of technical bids.
7. The bidder shall submit the sealed bid with requisite documents, including 2% Bid Security (or additional security if required of the estimated cost in the shape of a call deposit (original) before the closing date and time.
8. The bidders should submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
9. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring shall be considered as "non-responsive".
10. All the conditions/instructions given in the bid Solicitation documents shall be applicable on all competitive bidders.
11. The Procuring Entity (P.E) reserves the right to reject any or all bids, with cogent and valid reasons.
12. The bidder will provide an affidavit in the technical proposal that no Water Supply Scheme should stand un-operational for more than 24 hours. For which he should arrange sufficient stand by Pumping Machineries / other accessories/arrangements.
13. The application for visit of workshops will be submitted to the office of the undersigned three (03) days before closing date of tender submission.
