

**NOTICE INVITING TECHNICAL & FINANCIAL PROPOSALS E-BIDDING**

Public Health Engineering Division Kurram at Parachinar intends to invite Technical and Financial proposals from the PHE Department Khyber Pakhtunkhwa Pre-Qualified firms on single stage two envelopes system based for supply, installation, testing and commissioning of the solar based Pumping Machinerics to be installed in the water supply Schemes under the following ADPs:

Schemes details, Technical Specification and the design parameters of solar based pumping machinery for the water supply schemes are given in the bidding documents. Bidders may obtain bidding documents and further information from the office of the Executive Engineer PHE Division Kurram on any working day before the closing date.

1. Technical Design should be based on technical aspects, hydraulic parameters of the scheme provided in the technical documents and rates should be quoted accordingly in the financial bid.
2. Tender form/BOQ can be downloaded after publication in newspaper from Public Health Engineering website ([www.phedkp.gov.pk](http://www.phedkp.gov.pk)) only by the pre-Qualified firms/contractors
3. The contractors quoting their bids up to 10% below Engineer Estimate shall submit bid security 2% only of Engineer Estimate. The contractor quoting their rate more than 10% below & up to 20 % below of Engineer Estimate shall submit along with their bids 8% additional security of Engineer Estimated cost in addition to 2%bid security. If the bid is not accompanied with required amount of additional security, then bid will be considered non –responsive and 2% bid security shall be forfeited in favor of Government and 2<sup>nd</sup> lowest bidder and so on will be considered accordingly
4. The contractors quoting bid more than 20% below shall submit an additional security on Engineer Estimated cost equal to the differential amount Engineer Estimate and submitted bid (Differential amount: i.e., if a contractor quote 25 % below then he will submit 25% additional security of Engineer Estimate in addition to 2% bid security) along with detail rate analysis.
5. In case of more than 20% below bids, if the bid is not accompanied by detail rate analysis and/or required additional security the the bid shall considered non responsive and all other securities with such non responsive bid shall be forfeited in favour of Government and 2<sup>nd</sup> lowest bidder and so on will be considered accordingly, In case detail rate analysis submitted with bids is in view of procuring entity not convincing then Head of procuring entity may declare such bid non –responsive without any forfeiture of bid securities and record reason thereof.
6. Both (Technical + Financial) i.e., financial bid and technical bid separately sealed in envelopes should be submitted through Registered Mail/Couriers service to the office of the Executive Engineer PHE Division Kurram up to 12:00 pm on or before 11-06, 2024 Technical Bid will be opened at 12:00 pm on the same day by the bid's evaluation/procurement committee in the office of the undersigned in the presence of bidders or their representative opted to attend. Date of financial bids will be intimated accordingly.
7. Bidders may obtain bidding documents at a fee of Rs: 5000/- as per Govt: Rules payable through demand draft or pay order (Non-Refundable) in the name of Executive Engineer PHE Division Kurram
8. Firms/Contractor must be registered with KPRA (Active Tax Payer)
9. The tender forms and BOQs must be signed by the original qualified contractors / Firms.
10. All other Government of Khyber Pakhtunkhwa bidding/tendering rules will be applicable.
