
The works are offered Scheme wise. Details of schemes are as under: -

Date of financial bid opening shall be intimated accordingly.
3. Financial bid shall be submitted electronically through e-bidding not later than 19-09-2023 upto 12:00 Noon. The envelop mark as "Financial Proposal" must contain bid security @2% of the Estimated cost in shape of call deposit along with the stamp duty in the name of the Executive Engineer PHE Division Kohat and Non-refundable Bidding Entry Fee @0.03% of Tender Cost in shape of separate Call Deposit may be furnished (In Original) to this office.
