- 3 The bidder shall submit along with their bids, photo copy of PEC Registration, Enlistment, renewal for the year 2023-24, renewal of KPRA, FBR/ NTN, CNIC etc in sealed envelope through Courier Service, in parson or through special messenger to XEN PHE Division Kurram at Parachinar on or before closing date and time.
- 4 All notifications of the govt about taxes and other online E-bidding tender rules/ policy of KAPRA will be applicable on tender works awarded to contractor.
- 5 In case of identical rate of two or more than two bidders, their bids shall be evaluated on their technical soundness and experience or on toss basis.
