- Last Date & Time of Submission of the bid is 11-06-2024 at 12:00 PM, which will be opened on the same day at 02:00 PM in presence of the Contractors or their authorized representative who opt to be present.
- 4. The bid security, additional Security, and detail rate analysis (If the quoted rate is more than 20% below on the Engineer's Estimate) shall be submitted as per KPPRA Notification No. SRO(14)/Vol:1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022 alongwith the bid in a sealed envelope before the closing date and time to the office of the undersigned.
- 5. Non-refundable bidding entry fee @ 0.03% of the estimated cost must also be submitted furnished with bids in the shape of separate call deposit (in original) in the name of the Executive Engineer.
- Each bidder must attach 02% Original CDR, Letter Pad alongwith photocopies of CNIC, Pakistan Engineering Council
  Registration Certificate. Renewal Receipt, Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPPRA for the
  current year (2022-23) with each bid/work.
