



- Technical/Financial Bids shall be uploaded on EPADS
- An affidavit is mandatory in the Technical bid that the bid security and additional security (if required) is placed in the financial bid otherwise the bid will be considered as Non-responsive.
- The original bid security and additional security (if any) of all bidders shall be retained with this office until signing of contract agreement with the best evaluated bidder or till the validity period whichever is earlier as per KPPRA Notification No. S.R.O (29)/Vol:1-40/2025-26 dated 29-10-2025.
- The financial bids of only that firms/contractor will be opened on EPADS who stand qualified by the Technical Evaluation Committee.
- The content of the bids uploaded by the bidder on EPADS shall be vivid/readable.
- The bidders shall submit their bid security as per KPPRA Notification No. SRO (14) Vol:1-24/2021-22/ 6058-71 dated 10-05-2022.
