TERMS & CONDITIONS:-

1. Bidding documents including BOQ & instruction to bidders can be downloaded from PHED website www.phedkp.gov.pk.
2. A pre-bid meeting will be held on **14.01.2026** at **02:00 PM** in the office of the undersigned for all the tenders in the month of **Jan-2026**.
3. Bid will be opened in the presence of the Contractors or their authorized representative who opt to be present.
4. The Bid Security (in original), Additional Security (in original), and detail rate analysis shall be submitted as per KPPRA Notification No. S.R.O.(14)/Vol: 1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022, along with the bidding documents in a sealed envelope before the designated closing time of the Bid submission to the office of the undersigned.
5. As per Notification issued by KPPRA No. S.R.O. (29)/Vol: 1-40/2025-26 dated 29.10.2025, all bidders shall enter the details of the bid security and, where applicable, the additional security instrument in the E-PAK Acquisition & Disposal System (EPADS) at the time of bid submission. The original bid security and additional security instruments, details of which have already been entered in EPADS, shall be submitted to the procuring entity well before the closing date and time of bid submission. The procuring entity shall retain the original bid security and additional security instruments of all bidders until signing of the contract agreement with the best evaluated bidder or till the bid validity period whichever is earlier. (i) In case of failure to submit the original bid security instrument before the date and time, the procuring entity shall debar the bidder for a period of one (01) years. (ii) In case of violation for second time, blacklist him for a minimum period of three (03) years in accordance with section 29 of the KPPRA Act read with Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.
6. Each bidder must attach photocopies of PEC Registration Certificate (Valid), Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPRA with each work bidding document.
7. Incomplete / Conditional Bids with unattested cutting / overwriting/disfiguring shall be considered as Non-Responsive.
8. In case of equal rates of two or more bidders, their bids shall be evaluated on the best prevailing practices/toss base.
9. Bidders who fail to meet the specified conditions or submit incomplete documents in any aspect shall be liable to rejection.
10. The Competent Authority reserves the right to reject any or all the bids as per the provision contained in rule 47 of KPPRA Rules 2014.
11. Venue of Bid Opening is office of the Executive Engineer PHE Division Mardan.
