3. The bid shall also be submitted (electronically) through EPADS (uploading soft copy of submitted technical and financial proposals/bids) before last date and time for submission of bid, otherwise, the bidder shall be considered as non-responsive.
4. There shall be no variation between the original and copy of technical and financial proposal/bids. In-case of variation, the bid shall be considered as non-responsive.
5. The received technical proposals/bids shall be opened on the date and time for opening of technical bid in presence of bidders or their representatives who opt to be present.
6. The submitted technical and financial proposals/bids shall be evaluated according to the criteria mentioned in the BSD.
7. The bidder shall submit/quote their bids as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6038-71 dated Peshawar, 10/05/2022.
8. Clarifications/queries, if any, shall be asked/communicated through EPADS.
