3. The Bid Security (in original), Additional Security (in original), and detail rate analysis shall be submitted as per KPPRA Notification No. S.R.O.(14)/Vol: 1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022, along with the bidding documents in a sealed envelope before the designated closing time of the Bid submission to the office of the undersigned.
4. Non-refundable bidding entry fee @ 0.03% of the estimated cost must also be submitted/furnished with bids in the shape of separate call deposit (in original) in the name of the Executive Engineer.
5. Each bidder must attach photocopies of CNIC, PEC Registration Certificate, Renewal Receipt, Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPRA with each work bidding document.
6. The Competent Authority reserves the right to reject any or all the bids as per the provision contained in rule 47 of KPPRA Rules 2014.
7. In case of equal rates of two or more bidders, their bids shall be evaluated on the best prevailing practices/toss base.
8. Bidders who fail to meet the specified conditions or submit incomplete documents in any aspect shall be liable to rejection.
