GENRAL TERMS AND CONDITION:

- Biding Documents/BOQ including instructions to Bidder can be downloaded up to one day prior to last date from Public Health Engineering Department website: www.phedkp.gov.pk.. Bid should reach to office of the undersigned on or before 19/09/2024 before 12:00 PM. Bids will be opened on the same day at 2.00 PM in presence of contractor or their authorized representative who opt to be present.
- According to KPPRA rules the Contractors must be registered with KP revenue Authority (Active Taxpayer)
- 3. The bid security, additional Security, and detail rate analysis (If the quoted rate is more than 20% below on the Engineer's Estimate) shall be submitted as per KPPRA Notification No. SRO(14)/Vol:1-24/2021-22/6058-71 Dated Peshawar, the May 10th, 2022 alongwith the bid in a sealed envelope before the closing date and time to the office of the undersigned.
- 4. Bidder shall be registered with PEC, having renewal for the year 2024-25, having specialized codes such as CE-09, EE-04, EE-05, EE-11 required for electrical works as per criteria. (For works under Head-A)
- 5. Contractor must have enlistment duly issued by Provincial Enlistment committee, Khyber Pakhtunkhwa.
- 6. The non refundable bidding entry fee @0.03% in the shape of separate CDR of the tender cost should also be submitted along with the earnest money. In case not submitted the bid will be considered as non-responsive.
- The bid should accompany all necessary documents, i.e Electric License original copy of Class E issued by the Electric Inspector Khyber Pakhtunkhwa, Renewal of Electric license for the current year (2024-25) (For Electrical & Mechanical works). (For works under Head-A)
- 8. AM&R Contractor having workshop/ware-house at local level and adequate financial, human and logistic resources should be allowed to participate in AM&R bidding. (For works under Head-A)
- The Contractors shall submit Affidavit on Stamp-Papers duly attested by Oath Commissioners for Declaration of Ownership for Workshop/Warehouse. (For works under Head-A)
- 10. Each bidder must attach 02% of the estimated cost Original in the shape of CDR, Letter Pad alongwith photocopies of CNIC, Pakistan Engineering Council Registration Certificate. Renewal Receipt, Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPPRA for the current year (2024-25) with each bid/work, be submitted.
- 11. Scan copy of call deposit of 2% earnest money may be upload on E-bidding system. The CDR uploaded on E-Bidding system is required to submit the same CDR in hard form in this office, otherwise the bid shall be nonresponsive.
- 12. All the standing rules and regulations of the Government are applicable.
- 13. The competent Authority reserves the right to reject any or all the bids as per provision contained in rule 47 of KPPRA
