2. According to KPPRA rules the Contractors must be registered with KP revenue Authority (Active Taxpayer)
3. Last Date & Time of Submission of the bid is **23-01-2025 at 12:00 PM**, which will be opened on the same day at **02:00 PM** in presence of the Contractors or their authorized representative nominated duly in written form.
4. The bid security, additional Security, and detail rate analysis (If the quoted rate is more than 20% below on the Engineer's Estimate) shall be submitted as per KPPRA Notification No. SRO(14)/Vol:1-24/2021-22/6058-71 Dated Peshawar, the May 10<sup>th</sup>, 2022 alongwith the bid in a sealed envelope before the closing date and time to the office of the undersigned.
5. Non-refundable bidding entry fee @ 0.03% of the estimated cost must also be submitted furnished with bids in the shape of separate call deposit (in original) in the name of the Executive Engineer.
6. Each bidder must attach 02% Original CDR, Letter Pad alongwith photocopies of CNIC, Pakistan Engineering Council Registration Certificate having renewal (2024-25)and relevant codes. Department Enlistment Certificate, and Active Taxpayer Certificate of FBR and KPPRA for the current year (2024-25) with each bid/work.
7. The competent Authority reserves the right to reject any or all the bids as per provision contained in rule 47 of KPPRA rules 2014.
